

# **Privacy Policy**

At Projections Strategy LLP we are dedicated to safeguarding and preserving your privacy when visiting our site, providing services to you and communicating electronically with you.

This Privacy Policy, along with our terms of use, gives you the necessary insight as to what happens to any personal data that you provide to us, or we collect from you.

This Policy is updated from time to time so please check it regularly.

#### **Information We Collect**

In operating our website we may collect and process the following data about you:

- 1. Details of your visits to our website and the resources that you access, such as traffic data, location data, weblogs, IP address, operating system, what browser you are using and other communication data.
- 2. Information that you provide by filling in forms on our website, such as when you register to take up our annual membership, for information or make use of our services.
- 3. Information provided to us when you communicate with us for any reason.

#### **Use of Cookies**

We may gather information about your computer for our services and to provide statistical information regarding the use of our website to our advertisers.

Such information will not identify you personally, it is only statistical data about our visitors and their use of our site. This data does not identify any personal details whatsoever.

Similarly to the above, we may collect information about your basic internet use, by using a cookie file. These cookies are downloaded to your computer automatically and this file is stored on the hard disc of your computer. This helps us to improve our website and the services we provide to you.

All computers have the ability to decline cookies. This can be done by activating the setting on your browser which enables you to decline the cookies.

Our advertisers may also use cookies for which we have no control. Such cookies would be downloaded , once you click on advertisements, on our website.

This Website uses Google Adwords conversion tracking method, which uses cookies to monitor the success of our Google AdWords campaign. This tracking cookie is set on your browser only when you click on a Google Ad and these cookies help us increase the website's effectiveness for our visitors. These cookies expire within 30 days and do not contain information that can identify you personally.

### Cookies set on our sites by our commercial service providers

We use a range of third party services on our sites, from statistics, advertising, video delivery, content delivery and even low level, techie functions like load balancing our servers so they are always available when you want to use them. Some of these services require the use of cookies to work properly. These services include:

#### **Statistics**

**Google Analytics** provide anonymized statistical information for us. They process IP addresses and information from other cookies used on our sites so we know how many page views we have, how many users we have, what browsers they are using.

# **Social Media Tracking**

These are cookies that are used to collect certain non-personally identifiable information automatically for use on the "Add This Platform". This enables us to better understand how people are consuming and sharing our content socially and which content is more popular.

## **Third Party Links**

The advertisements on our sites are served by a number of third party ad serving providers. The cookies accompanying the ads allow them and their advertisers to monitor the effectiveness of the ads and make the ads more relevant to you.

# General third party opt-outs

You can learn about and opt out of a number of commercial third party cookies. Some of the opt-outs used by our commercial service providers require a cookie to be placed on your PC which is only used to tell the relevant cookie servers not to send you any further cookies.

### **Use of Your Information**
