- The Performa invoice will be sent to your email account after your payment has been processed.
- The moment we receive confirmation of receiving the amount we will send you the password by which you will get complete access to the website.
- The password is exclusively meant for your use only.

PLACING ADVERTISEMENT.

- After you have decided to place your advertisement in our website we will send you the Performa invoice via email for your confirmation.
- You must finalize the artwork of your advertisement at least 3 weeks before the due date of the advertisement.
- The payment must reach our account minimum two weeks before the final date of appearance.

OFFLINE SERVICES

- After you decide to make use of any services, please let us know and we will send you the Quotation via email, along with the term and conditions of payment for your confirmation (the chargeable amount will vary on case to case basis).

- You must finalize and confirm the acceptance of our prices and the terms of payment.
- The advance payment must reach us well in time so that we can start working on your required services and complete them in time.

CANCELLATIONS AND REFUNDS

- Where a minimum term of 12 months is advertised for annual membership, cancellations are not permitted until the end of this initial period and we will not issue you a refund. Should you wish to cancel after the minimum term, please inform /contact our customer care team in writing.
